**學生津貼(2021/22 學年)**

就著教育局於2021年9月20日發出的通函，公布有關在2021/22學年為日校學生提供的2,500元學生津貼的事宜，本校現特函通知 貴家長有關申請安排。是項學生津貼不設資產審查。所有在申請日在香港就讀於本地或非本地課程的中學日校、小學和特殊學校及幼稚園的學生皆可獲得有關津貼，但如學生是持有入境事務處發出擔保書(坊間一般稱為「行街紙」)，則不符合資格。

申請表會由班主任派發給學生，每名學生將收到一張「表格B」或「表格A」。如學生不符合資格申請學生津貼，將不會獲發任何表格。所有填妥的申請表格必須交回學校，經由學校核實學生身分，教育局才會處理有關申請。

表格 B 上已預印學生及申請人的基本資料(原校就讀的學生適用)；表格 A 屬空白表格(本學年取錄的新生或插班生適用)。請家長/監護人按照下列情況填寫申請表：

(甲) 表格 B (樣本見附錄一)：

- ✧ 一般情況下，家長/監護人只須核對所載資料正確無誤，及**選擇接收短訊通知的語言**。如預印資料沒有更改，便可**在表格底部的指定確認方格加上「✓」號，並簽署確認**，然後交回班主任，無需重新填寫資料。
- ✧ 如表格 B 所列部分資料需要更新(學生英文姓名以外的資料)，家長/監護人請在有關資料的上方位置用**黑色或藍色原子筆以正楷作出修正(請勿使用塗改液或改錯帶)**，並**漏空表格底部的確認方格**，然後將表格交回班主任。
- ✧ **如表格 B 所列的學生英文姓名需作更改**，有關學生的家長/監護人需填寫表格 A 申請。如有此情況，請向班主任索取一張「表格A」填寫。

(乙) 表格 A (樣本見附錄二)：

- ✧ 新入學學生、插班生、個別沒有獲教育局提供表格 B 的學生，或上述需要修改主要資料(即學生英文姓名)的學生，家長/監護人需填寫表格 A 申請。家長/監護人在填寫申請表格時，請參閱已上載教育局網頁的參考資料(包括如何正確填寫銀行戶口資料)(<http://www.edb.gov.hk>) (主頁 > 學生及家長相關 > 支援及資助 > 學生津貼)。請將填妥的表格交回班主任。

當填寫申請表格時，請注意以下事項：

- (1) 申請人必須是學生的父母或監護人。
- (2) 請用**黑色或藍色筆以正楷填寫申請表格**。請勿使用塗改液或改錯帶。如有修改，申請人須在旁加簽作實。
- (3) 申請人的英文姓名必須與銀行紀錄的帳戶持有人名稱相同，否則自動轉帳可能會被拒絕。
- (4) 申請人必須填寫表格內所有各項資料，並在表格上簽署。如表格上的資料不完整、不準確或不正確，可能會令其申請延遲或無法處理。

- (5) 請參考附上的「一般銀行編號表」(附件三)，填寫正確的銀行編號。
- (6) 請掃描以下二維碼觀看有關「如何填寫申請表格(包括如何正確填寫銀行戶口資料)」的介紹短片。

Dear Parents/Guardians,

**Student Grant (2021/22 School Year)**

In respect to the circular memorandum dated 20 September 2021 from the Education Bureau, the school was informed about the arrangements of providing day-school students with the student grant of \$2,500 in the 2021/22 school year. Please note that the student grant is non-means-tested. All students who, as at the date of application, study in secondary day-schools, primary schools, special schools and kindergartens are eligible for the grant. However, students who are holders of Form of Recognizance issued by the Immigration Department are NOT eligible.

Each student will receive either a “Form B” or a “Form A” from the class teacher. If a student is not eligible for the student grant, he/she will not be issued any form. All completed application forms have to be submitted to the Education Bureau through the school as we are required to certify the student concerned is our student.

Form B is pre-printed with the basic information of the student as well as that of the applicant (applicable to students who have been studying at our school since last school year or before) while Form A is a blank form (applicable to students who are newly admitted or transferred to our school in this school year). Parents/guardians are advised to fill in the application forms according to the circumstances set out below:

**(A) Form B (sample at Appendix 1):**

- ✧ In general, parents/guardians are only required to check the accuracy of the pre-printed information and **choose the language of SMS notifications**. If there is no change in the information pre-printed, **put a “√” in the confirmation box** at the bottom part of the form, **sign to confirm** and submit the application form to the class teacher. There is no need for parents/guardians to fill in the information anew.
- ✧ If some of the pre-printed information on Form B requires updating (information other than Student’s Name in English), parents/guardians have to provide the amendment(s) in the space above the relevant information in **BLOCK letters** using **black or blue ball pen (correction fluid or tapes should not be used for making amendment(s))**, **leave the confirmation box at the bottom part of the form blank** and submit the application form to the class teacher.
- ✧ If Student’s Name in English pre-printed on Form B requires amendment(s), parents/guardians of the students concerned **should use Form A for application**. You may obtain a Form A from the class teacher.

**(B) Form A (sample at Appendix 2):**

- ✧ For students who are newly admitted or transferred to our school, individual students without Form B provided by the EDB or those with the aforementioned essential particulars (i.e. Name in English) requiring amendment(s), parents/guardians should use Form A for application. In completing the application form, parents/guardians may refer to the reference information (including how to fill in bank account information correctly) uploaded onto the EDB website (<http://www.edb.gov.hk>) (Home > Students and Parents Related > Support and Subsidies > Student Grant).

Please note the following points when completing the application form:

- (1) The applicant must be the parent or guardian of the student.
- (2) Please complete the application form **in BLOCK letters using black or blue pen. Avoid using correction fluid or tapes. Any amendments made must be counter-signed by the applicant.** It is advisable for the applicant to keep a copy of the completed form for future reference.
- (3) The **applicant's name in English** must be the **same as the account holder name registered with the bank**, otherwise autopay may be rejected.
- (4) Please fill in all parts of the application form and sign it. Failure to provide the required information, or if any information is found to be false, incomplete, inaccurate or incorrect, may result in delay or non-processing of the application.
- (5) Please fill in the correct bank code. A "Common Bank Code List" (**Appendix 3**) is attached for your reference.
- (6) You may watch the video on how to fill in the application form (including how to fill in the bank account information correctly) by scanning the QR codes below.
